A RESOLUTION REQUESTING THE COUNTY AUDITOR TO MAKE TAX ADVANCES DURING THE TAX YEAR 2023 PAY YEAR 2024 PURSUANT TO SECTION 321.34 OF THE OHIO REVISED CODE

WHEREAS, the Ohio Revised Code allows a local taxing authority to request advance payment from the County Auditor of funds derived from taxes or other sources to the County Treasurer, which may be held on account of a location subdivision.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Lowellville, Ohio, six members thereto concurring:

Section 1. That the Auditor and the Treasurer of Mahoning County, in accordance with Ohio Revised Code Section 321.34, be required to draw and pay to the Village of Lowellville, upon the written request of the Clerk Treasurer to the County Auditor, funds due and any settlement of tax year 2023 pay year 2024 derived from taxes or other sources payable to the County Treasurer to the account of the Village of Lowellville and lawfully applicable for purposes of the current fiscal year.

Section 2. That the Clerk Treasurer is hereby directed to transmit a certified copy of this Resolution to the Auditor of Mahoning County, Ohio.

Section 3. That this Resolution shall take effect and be enforced from and after the earliest period allowed by law.

Ordinance No. 4116

AN ORDINANCE AUTHORIZING THE MAYOR AND VILLAGE ADMINISTRATOR TO ENTER INTO A CONTRACT WITH MS CONSULTANTS, INC., FOR ENGINEERING SERVICES FOR THE CALENDAR YEAR 2024 AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Lowellville, Ohio, 3/4's of all members thereto concurring:

SECTION 1: That the Mayor and Village Administrator are hereby authorized to enter into a Contract with MS CONSULTANTS, INC., for engineering services for the calendar year 2024.

SECTION 2: A copy of said Agreement is marked Exhibit "A" and attached hereto and made a part hereof.

SECTION 3: Payment for said engineering services when needed shall not exceed \$ 16,095.00 and shall be expended from the SEMAR fund.

SECTION 4: Said Contract will expire on the 31st day of December, 2024 according to provisions in this Agreement.

SECTION 5: This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of the inhabitants of the Village of Lowellville, Ohio. Said emergency exists by reason of the fact that said engineering services are needed immediately and, as such, this Ordinance shall take effect immediately upon its passage and approval by the Mayor.
